

Certificate II in Construction Pathways CPC20220



COURSE DESCRIPTION & PATHWAYS

This pre-apprenticeship course provides students with the basic operational knowledge and the development of skills applicable to a broad variety of trades within the building and construction industry. The course involves both theory and practical skills in building and construction, with an emphasis on carpentry.

This qualification provides a pathway to the primary trades in the construction industry with the exception of plumbing. Trade outcomes are predominantly achieved through an Australian Apprenticeship and this qualification allows for inclusion of skills suited for entry to off-site occupations, such as joinery as well as carpentry, bricklaying and other occupations in general construction.

VET for School Students - (VSS)

The CPC20220 Certificate II in Construction Pathways is supported by the Government of South Australia and is available for eligible VSS Students.

To be eligible for access to a subsidised training place, a school student must meet the following criteria.

They must be:

- An Australian or New Zealand citizen or,
- A permanent Australian resident or,
- An eligible visa holder
- Reside in South Australia

They must also be:

- enrolled in Year 11, 12 or 13 and be 16 years of age or turning 16 years of age in the current year of that enrolment, and
- undertaking SACE or equivalent and,
- have completed a preparatory VET pathway please refer, VET for School Students Approved Evidence for Completion of a Relevant VET Pathway Guide, (available from your VET Coordinator)

Whilst at school the secondary school student can access a total of one Certificate II course and one Certificate III course. If a secondary school student completes 70% of a course and exits without completion, they will consume one of their course entitlements.

Acceptance into a subsidised course will be determined through the VET Readiness Orientation process (VETRO). This will occur following receipt of a completed VET for School Student Referral to Training Form from the secondary school.
